As a college community, we have experienced a great deal of changes in the last few years and today we share news of another transition. Chancellor Dr. Sonya Williams has made the decision to leave her position for personal reasons. We thank Dr. Williams for her service.

The Board of Trustees has appointed Dr. Naomi DeWinter, Muscatine Community College President and Vice Chancellor of Student Development, to serve in a temporary role as acting chancellor. The Board has full confidence in Dr. DeWinter and the entire leadership team. Dr. DeWinter has the right mix of skills and experience to lead us forward.

In the coming month, the Board will actively participate in the process of selecting and appointing an interim chancellor.
