Program Description

The Emergency Medical Services (EMS) AAS program prepares graduates for successful completion of the National Registry EMT Psychomotor and Cognitive Examinations as well as the National Registry Paramedic Psychomotor and Cognitive Examinations. With passing results, the student will receive State of Iowa EMT and Paramedic certifications. The Paramedic is the highest trained pre-hospital care provider in the State of Iowa.

Graduates will have the tools to adapt to public expectations and to take leadership roles in the evolution of prehospital patient care and may experience enhanced career opportunities. They will be equipped with the skills and knowledge necessary to take proactive roles in Emergency Medical Services research, quality improvement, public education, and system management.

The Emergency Medical Services (EMS) programs are accredited by the Commission on Accreditation of Allied Health Education Programs (CAAHEP) upon the recommendation of the Committee on Accreditation of Educational Programs for the Emergency Medical Services Professions (CoAEMSP).

Admission Requirements

In addition to the general admission requirements of the college, applicants to this program must meet specific program admission criteria. The Paramedic, Diploma is an advanced standing award. Students must possess a current Iowa Emergency Medical Technician (EMT) certification for admission consideration.
